MARCH 21, 2018 IS THE DEADLINE TO TENDER A NEGOTIATED PLEA. ANY GUILTY PLEA ENTERED AFTER THIS DATE WILL BE NON-NEGOTIATED.

Criminal Jury Trials will begin on **Monday, March 26, 2018 at 9:00 a.m.** and will continue from day to day until completed. This is a two-week trial calendar continuing through and including **April 6, 2018**. Each defendant and his or her counsel shall attend and remain in Court until said defendant's case is tried, unless otherwise placed "on-call" by the Court.
